Expungement (Fee Waiver - Must qualify)	A live scan for expungement where the California Department of Justice fee is waived for eligible individuals to reduce cost barriers.	\$12	\$50	\$62.00
Expungement (No Fee Waiver)	A live scan used to process fingerprinting required to clear or dismiss eligible criminal records through the court.	\$32	\$50	\$82
Visa / Immigration	Required for immigration or visa applications to verify identity and review criminal history for federal processing.	\$32	\$50	\$82
TRUSTLINE	A fingerprint background check for in-home childcare providers to be registered with California's TrustLine registry	\$64	\$50	\$114
Background check for Volunteers	Used by organizations to screen volunteers for safety and eligibility before service.** Human Resource Agency/Youth Organization inquire	\$32	\$50	\$82
Board of Register Nursing	For nursing licensure to ensure applicants meet background check standards set by the state board.	\$49	\$50	\$99
